Minutes of the 69th Meeting of the Approval Committee (01/2024 series)
of Mangalore Special Economic Zone held on 19.02.2024

The 69th Meeting (01/2024 series) of the Approval Committee of Mangalore Special Economic Zone Limited constituted under Section 13 of the Special Economic Zones Act, 2005, was held on 19.02.2024 through video conferencing under the Chairmanship of Smt P Hemalatha IAS, Development Commissioner, MSEZ.

At the outset, the Chairman welcomed the members of the Approval Committee to the meeting. The following items in the agenda, circulated in advance, were taken up for consideration:

A. Confirmation of the minutes of previous meeting:

The minutes of the 68th meeting of the Approval Committee (05/2023 series) held on 19.12.2023, were circulated and confirmed.

B. Action taken on decisions of the previous meeting:

Action taken on the decisions of the 68th meeting held on 19.12.2023 were noted by the Committee.

C. Proposals for consideration:

Item No.1: Request of M/s Mangalore Refinery and Petrochemicals Limited, a unit in Mangalore SEZ for purchase and service of Ambulance in their unit.

The Committee after due deliberations approved the proposal of M/s Mangalore Refinery and Petrochemicals Limited (erstwhile M/s ONGC Mangalore Petrochemicals Limited), a unit in Mangalore SEZ for duty free purchase of Ambulance worth Rs.24.00 lakh (excluding IGST) and inclusion of the Ambulance Service, as additional list of services for authorized operations of the default list of services, as per DoC's Instruction No.79 dated 19.11.2013, subject to the condition that this service is for the exclusive use of the SEZ unit.
